We herewith would like to thank and inform that we have received the medical report about Mrs. Chelidze. We forwarded all medical documents to our chief physician PD. Dr. med. Reichardt (Department for oncology).

He advises the patient to come to the HELIOS Private Hospital for further medical examination and consultancy. As can be seen from the medical documents, Mrs. Chelidze suffers from an unclear neof ormation in her upper left abdomen (main diagnosis: metastasized sarcoma of the lower leg). Furthermore, Mrs. Chelidze is in her 27th week of pregnancy with twins.

According to our physicians, Mrs. Chelidze urgently needs surgery due to the unclear neof ormation in her upper left abdomen. Should it come to a premature delivery of her twins, a neonatologic treatment and support of unknown time will be necessary. As a result of the complexity of her diagnosis and the increased risk for all patients, we cannot base the non-binding preliminary invoice on a DRG. Already the costs for the newborns in the neonatologic department cannot be estimated at this point in time.

Please be advised that we cannot prepare a detailed cost estimate at this point in time. It is not possible to provide a cost estimate that is based on a DRG (Diagnosed Related Group) according to the German billing system. However, as soon as we know the treatment plan for Mrs. Chelidze, we will immediately provide the patient with a detailed cost estimate. For now we kindly ask you to make a deposit payment of the below stated amount.

Please be advised that the below stated costs are only an estimate and may differ from the final sum:

The first down payment of 108.513,29€ should be made by the 03.04.2015, the remaining balance has to be paid to our bank account by the 15.05.2015.

We kindly inform you, that this **preliminary invoice is non-binding**. In case of unforeseen complications, the final costs of treatment can deviate from the costs calculated in the non-binding preliminary invoice.

Costs for the use of telephone services are not included in the non-binding preliminary invoice and will be charged separately.

We ask for a 100% deposit payment of the above mentioned amount before the arrival of the patient. Please mention the patient's name and date of birth on the transfer form.

A detailed invoice will be provided after the patient's discharge.


